Detail of Operations

Nearshore Geophysical Survey

Mariners are advised that the M/V Titan Endeavour will mobilise for nearshore survey work on 14 September 2011. The vessel will operate from Bridlington Harbour.

The survey duration is estimated at 15 days. Operations will be for 12 hours per day only, although the start and end times of work will vary with the tides. Shallow water operations will take place during high tides. Any work conducted close to static fishing equipment will be performed during daylight hours only.

During the survey the vessel will be operating a surface-towed boomer with hydrophones and a hull-mounted multibeam echosounder. The boomer and hydrophones will be deployed on either side of the vessel, no equipment will be towed behind the vessel.

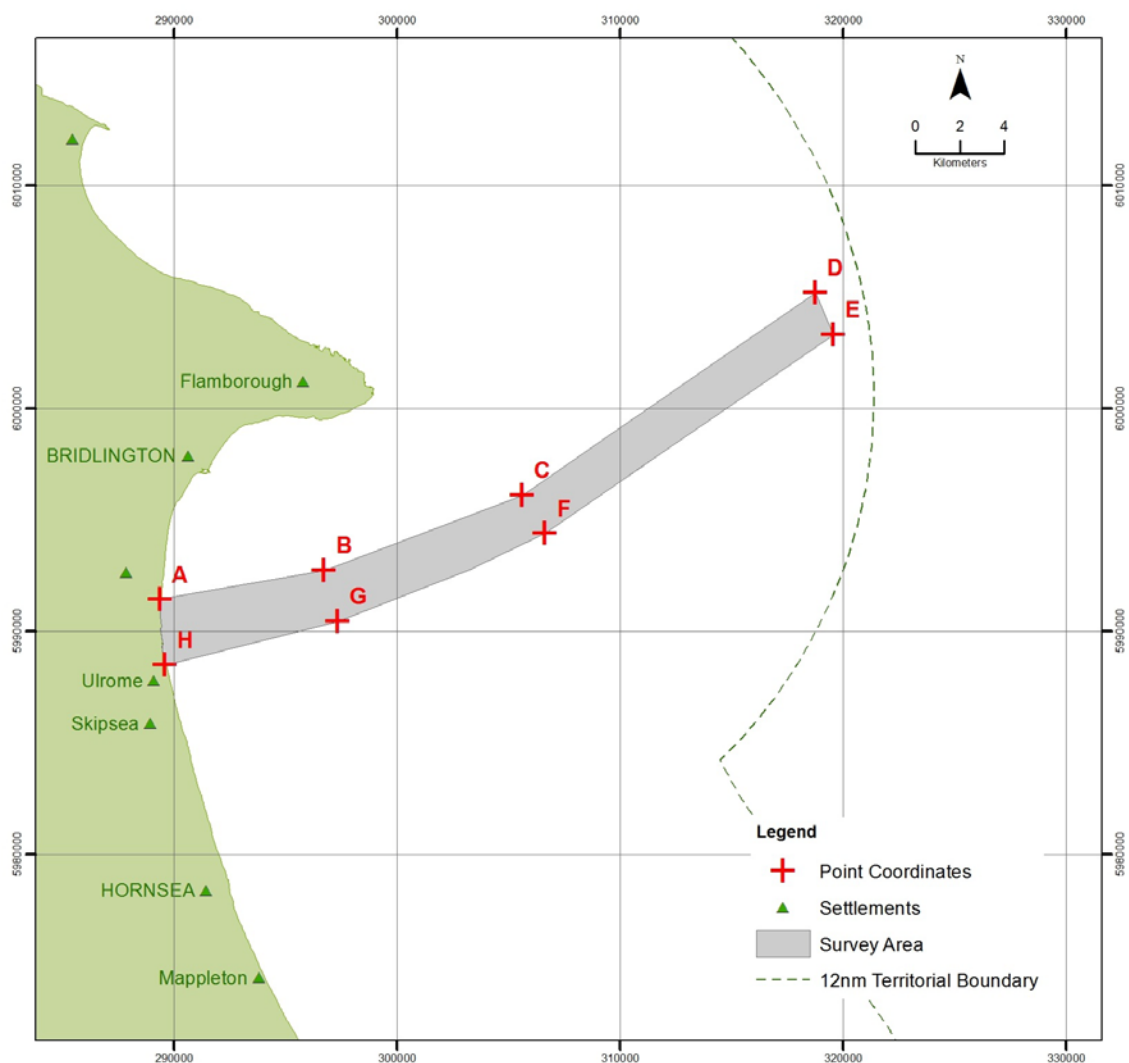


Figure 1: Above; survey area plan for near-shore geophysical survey activity – MV Titan Endeavour
